MINUTES OF THE 25THMEETING OF THE EXECUTIVE COUNCIL OF SMVDU

- The 25thmeeting of the Executive Council of Shri Mata Vaishno Devi University (SMVDU) was held on 14th November, 2016 at 10:30 A.M. in the Executive Council Room, Matrika Auditorium, SMVD University Campus, under the Chairmanship of the Governor N. N. Vohra, Chancellor SMVDU.

- Prof. Goverdhan Mehta and Prof. R.D.Sharma, could not attend the meeting and were granted leave of absence.
- Dr. Sanjeev Jain, Vice Chancellor, welcomed the Chancellor and all the members and invitees and requested the Chancellor to chair the 25thmeeting of the Executive Council (EC).
- 5. The Vice Chancellor (VC) then asked the Registrar to make the presentation on the achievements of the University after the last meeting of the EC. While appreciating the progress made by the University, the following observations were made by Chancellor and members of Executive Council.
 - i. While noting the status of admissions for the year 2016-17, the EC expressed serious concern over the continuing rapid decline in number of students admitted from outside the state of J&K during the last few years. Chancellor observed that a well thought out approach was required to attract meritorious students from the top bracket and desired that a separate meeting of the EC be convened to discuss the matter in detail and to consider a policy frame for admissions for the next academic year.
 - ii. EC observed that it will be desirable to have at-least one Professor in every Department before the University applies for NAAC Accreditation as the process of accreditation by NAAC has become very stringent, and directed that vigorous efforts be made by the VC in this regard. An appropriate policy would need to be prepared so that faculty in the age group of 65-70 years could also be appointed through direct recruitment or on deputation for 3-5 years from prestigious institutes. The appointment of Professors from amongst persons with outstanding experience in the Corporate Sector could also be explored in terms of academic equivalence. With a view to attracting senior faculty of high standing from IITs and other similar reputed institutes, a financial package should be worked out which may be 25% over and above the salary package payable for the post of Professor in IITs. Such potential senior faculty members may be identified and invited to the University for guest lectures and the University shown to them for a first-hand view of the facilities available in the Campus as also the medical facilities now available in the adjoining SMVDNSSH.
 - iii. EC further directed that, with a view to attracting good faculty, while ensuring compliance with the minimum standards and eligibility criteria of UGC, the University should formulate an appropriate policy for assessing the suitability of faculty members for promotion by laying down criteria to assess exceptional academic achievement such as Consultancy work done, Research funding obtained, publications in SCI/Scopus index journals,


MOOC certification, attending FDP's etc. Chancellor desired that a comprehensive proposal in this regard be placed before the Academic Council for its consideration and its recommendations be put up to the Executive Council.

- iv. EC was informed that IIT Jammu, which has recently started functioning, is inviting the Professors in various subjects from outside to visit Jammu for taking classes. The University should also invite Visiting Professors from nearby reputed institutions, like IIT Delhi etc., for teaching a course in the relevant subject where there is shortage of faculty at the senior level, by offering suitable remuneration/incentives.
- v. EC suggested that the University should approach Ph.D. students who are about to pass-out from IITs to fill the vacant positions of Assistant Professors in various departments. Copies of advertisements for recruitments at the level of Assistant Professor should be sent to the various IITs in the country for information of the passing out / passed out Ph.D. students.
- vi. EC directed that the University should regularly organize Alumni meets and invite the Alumni who have accomplished notable milestones in their respective fields for guest lectures, interactive sessions etc. by considering them as Distinguished Guests/Distinguished Visiting Faculty.
- vii. EC suggested that the University should adopt a new method of teaching-learning by creating a local cloud to facilitate the students in their learning. The University should also develop an offline repository of NKN lectures which should also be accessible to students at any time. Webcast of Lectures in IITs should also be recorded. It was further desired that at least 10% of the lectures will be out of MOOC and NPTEL resources which should be made mandatory for faculty members. FDP be arranged for faculty members to equip them with proficiency in smart class rooms and appropriate incentives given to those faculty members who come forward to record their lectures to students in the University. Faculty should also be encouraged to attend the FDPs in important areas in IITs / NITs and other Institutes of the national repute for 2 weeks duration.
- viii. Chancellor desired that the online resources of Harvard University and other world renowned institutions could also be explored for online lectures of the subject experts for the students of SMVDU. If the same is not permissible, the recorded lectures as available in their websites should be downloaded and used as one of the teaching resources for the students. The possibility of having classes upto 8:00 P.M. be also explored on the lines of the practice already being followed in many ITs.

- ix. Chancellor directed that every Department should have its own E-classroom/Smart classroom. The requirement of smart classroom and laboratories be reviewed and a proposal for further extension of facilities in the academic block be put up in keeping with the norms of the regulatory bodies.
- x. Chancellor desired that the University should also work out the details of a project for construction of an indoor stadium with facilities like Table Tennis, Squash Court, Badminton Court, Skating Ring, Handball Court and Swimming Pool etc. with other basic amenities.
- xi. Chancellor desired that the quality and rates of the newly opened food outlets should be closely monitored and regulated. He further directed CEO, SMVDSB, to discuss the matter with M/S Sagar Ratna (whose outlet is already in place at the Holy Shrine at Bhavan) to further lower the rates in its outlet being shortly opened at SMVDU Campus.
- xii. Chancellor desired that all the girl students who have been adjusted in the residential accommodation (Staff Quarters)of the University for the time being should be shifted to Girls Hostel by next year.
- xiii. Chancellor desired that VC and CEO, SMVDSB, should jointly explore the possibility of securing Medical Insurance for the students at the minimum possible premium and Medical Cards got issued to them for treatment at SMVDNSSH.
- xiv. EC directed that University should early explore the feasibility of switching over to LED bulbs in the Campus in a phased manner to reduce the electricity bills. The University should also expedite feasibility of setting up a 1MW Solar Roof Top Power Plant by utilizing the subsidy available under the schemes of MNRE (GOI).
- xv. EC directed that each faculty member should have at least one or two good research projects. The University should explore the possibility of incentivizing faculty members who produce good research work.
- xvi. EC directed that University to take urgent necessary steps to make SMVDU-TBIC fully functional. It was suggested that each student, particularly M.Tech. students, and faculty member of the University, should be encouraged to take projects under SMVDU-TBIC. It was suggested that one such project could be for controlling the monkey menace at the University and at the tracks enroute the Shrine. The TBIC should also have a Design Centre. All M.Tech. projects, as far as possible, should be connected with the Incubation Centre.



Chancellor desired the VC to widely publicize the Incubation Centre. The University should also organize a seminar regarding TBIC, wherein J&K CII, ASSOCHAM, FICCI, SKUAST-J/K and State Industries Associations should be invited to discuss the possible ways to promote the productive usage of TBIC.

- xvii. EC desired that Placement Agencies be invited for setting up their Centres in the University so that students can easily take projects in these Centres which will ultimately help them in getting good placements. The Chancellor desired the VC to take all necessary steps to see that the University improves its standing and also bring about improvement in the average value of the package being offered to our students by the companies visiting the Campus. Feedback of the Companies who have already visited the University should also be obtained.
- xviii. It was desired by the Chancellor that the University should draw a plan for undertaking plantation of forest trees, flowering trees, flowering shrubs, creepers and varied flowers (some of which should be hardy annuals) in an organized manner, in the whole Campus especially in the areas where, as per the Master Plan, buildings are not proposed to be constructed.
- xix. EC resolved that renowned persons should be invited for Convocations of the University and awarded Honorary Degrees to make the University widely known outside J&K.
- xx. EC suggested that the Faculty should be encouraged to take up Consultancy work and the University should identify the areas in which it needs to improve and maintain its standards. It was also suggested that the process of NBA accreditation for MBA program can be initiated early, as the "Management" format has not yet been changed while other formats have already been revised and have become more stringent.
- xxi. EC desired that the VC should early promulgate outcome-based realistic targets for the Key Result Areas (KRAs) and Key Performance Indicators (KPIs), valid for the next three years, such as Research Funding Proposals, Funds to be generated by Consultancy, Growth and Development etc.

6.1.1 Executive Council (EC) confirmed the Minutes of the 24th meeting of the Executive Council held on 23rd November, 2015.

ACTION TAKEN REPORT

- Item No. 25.2 Action Taken Report on the decisions taken in the 24th meeting of Executive Council held on 23rd November, 2015
 - **6.2.1** While noting the reported position on various issues in the Action Taken Report, the following observations were made:
 - I. Online Feedback (Point 5):EC desired that Feedback of the faculty members given by the students as obtained and monitored by IQAC should be examined by the Vice Chancellor along with the Deans of the concerned faculty. HsoD should also sit randomly in classes of faculty members and submit his observations to VC. It was also suggested to constitute Class Committees which shall regularly meet the concerned HoD for reviewing and discussing the feedback regarding those faculty members regarding whose teaching the students are facing problems. Vice Chancellor may issue advisory/warning letters where ever required, and if there is still no improvement, poorly performing faculty may even be discharged from the services of the University.
 - II. Annual Calendar of the University. [Item No. 24.2 sub item 6.2.1 (I)]

EC desired that the Academic Calendar of the University should be revised to include national / international events. It was further suggested that the dates for Industry-Academia interaction should also be included in the Academics calendar. Chancellor desired that the 2017 calendar for extracurricular activities and meetings of the statutory bodies be submitted to him.

III. Proposal to set up Hoardings. [Item No. 24.2 sub item 6.2.1 (V)]:

Chancellor desired that the installation of hoardings (English and Hindi language) at identified locations enroute the track be expedited by CEO, SMVDSB and VC should ensure action.

IV. NAAC Accreditation. [Item No. 24.2 sub item 6.2.1 (VII)]:

Chancellor desired that before the University applies to any of the Accreditation bodies, it should prepare itself thoroughly especially in respect of appointing an adequate number of senior faculty(Professors/ Associate Professors) in each Department/School. EC also advised that the University should have its own formula for admitting NRIs after examining and formulating an appropriate equivalence test for NRIs. However, the legal framework of the Govt. of India for admitting NRIs/Foreign student be kept in view. The possibility of AICTE and other funding agencies providing scholarship for foreign students studying in J&K be also explored.

V. Annual Account (Balance Sheet) for the FY 2013-14 (Exemption from Service Tax on Mess Fee) [Item No.24.2 sub item 6.2.1 (viii)]

Chancellor desired that the matter be followed up with Commissioner/Secretary, Finance Department.

VI. Review of Students Merit-cum-Means Scholarship Scheme (SMMSS) [Item No. 24.3 sub item 24.3.1 (6.3.1.1 & 6.3.1.2)]

Chancellor desired that the University should undertake a comprehensive review of strategy on all scholarships to attract the meritorious students and put up for discussion in the Special Meeting of the EC to be held in January 2017.

VII. Adoption of UGC Choice Based Credit System (CBCS) at SMVDU. [Item No. 24.3 sub item 24.3.2 (6.3.2.1)]

It was suggested that the curriculum for Engineering Programs may be reviewed as it needs to be reorganized. It was suggested that 40% of the Curriculum should comprise of Core Courses and a framework worked out to rationalize total credits with flexibility, to the extent feasible, to allow the students to complete the program at their own pace.

VIII. Introduction of Scheme of Inter-University Credit transfer at SMVDU [Item No. 24.3 sub item 24.3.4 (6.3.4.1 & 6.3.4.2)]

While noting the reported position, Chancellor asked VC, University of Kashmir, to convene a meeting of the VCs Forum to explore the possibility of applicability of the scheme within the Universities established in the State, in the first instance. The University may explore the possibility for implementation of the same with other Universities/Institutes of Higher Education outside the State and also with foreign Universities.

IX. Continuation of Admission of Ms. Apoorva Jamwal, provisionally admitted to Five-Years Integrated M.Sc. (Economics) program and Framing of policy for such cases for future. [Item No.24.3 (24.3.16.1 & 16.2)]

Chancellor desired that the University should have a regular policy in this regard to ensure that individual cases are not required to be taken up.

X. Augmentation/Improvement of Water Supply to the Campus [Item No. 24.6 sub item 24.6.5 (6.6.5.1)]

Chancellor desired that a study be conducted to ascertain the time period up to which the underground water at the site of the bore wells is likely to sustain sufficient discharge of water to meet the needs of the University.

XI. Proposal for Establishment of Human Resource Development (HRD) Centre at SMVDU [Item No. 24.6 sub item 24.6.10 (6.6.10.1)]

Chancellor desired that the concrete objectives, types of programmes to be undertaken by HRD Centre should be clearly defined and it should undertake more programs on regular basis. Further, the calendar of various programs for the next year be prepared immediately for its dissemination amongst the potential participants in its programs.

XII. Appointment of Adjunct Professors in the different Schools at SMVD University. [Item No. 24.23 sub item 6.23.2]

EC approved the payment of remuneration to Adjunct Professors and Visiting Professors @ Rs. 5,000/- per lecture of one hour with a maximum ceiling of Rs. 10,000/- per day for maximum 30 lectures in a Semester.

XIII. Consideration of finalization of 10 years perspective plan 2015-2025

Chancellor desired that the matter be discussed in a separate meeting of EC to be convened sometime in the month of Jan 2017 at Delhi. A copy of the Perspective Plan be given to the EC members before the meeting. Chancellor further desired that status of admissions in various courses be also discussed in this Special Meeting.

XIV. Proposal for affiliation of the proposed Nursing College and Medical College to be set up at Shri Mata Vaishno Devi Narayana Super speciality Hospital by the Shri Mata Vaishno Devi Shrine Board. [Item No. 24.27 sub item 6.27.1]

EC noted the reported position and observed that once the Medical College of SMVDNSSH comes up it will have to be necessarily considered as a Constituent College of the University and not as an Affiliated College. Chancellor directed

will work out and define cutoff marks for eligibility to avail the Assistantship in accordance with the UGC/AICTE guidelines/rules. Yearly contingency will be payable only if permissible under UGC/AICTE guidelines/rules.
