**Subject: Taking up the SWAYAM Courses for credit transfer - regarding**

As you are aware, Ministry of Human Resource Development has initiated SWAYAM for online MOOCs Courses. Also UGC & AICTE has also issued Regulations, 2016 (Credit Framework for Online Learning Courses through SWAYAM), to allow credit transfer up to 20% on the basis of MOOCs on SWAYAM. Under Career Advancement Scheme (CAS) of UGC, Creation of MOOCs Course or undergoing training through MOOCs is also recognised as one of the eligibility criteria for promotion of faculty.


