Sub: Revised Selection criteria for admission to the B.Tech. Programs being offered by the SMVD University for the session 2020-21 in lieu of SMVDUEE 2020

Ref no.: Minutes of Meeting of Central Admission Committee held on 15th June 2020.

In view of the circumstances caused due to COVID 2019 pandemic leading to infeasibility of timely conduct of the written SMVDUEE 2020 Entrance Examination for admission to the B.Tech. Programs at SMVDU for the session 2020-21, the revised selection criteria (in lieu of SMVDUEE 2020) for admission to the various B.Tech. programs is notified as under:

| Program | Selection Criteria and Merit List |

| B.Tech. | <p>Selection to a suitable number of seats for various B.Tech. programs earlier meant to be taken through SMVDUEE-2020 will now be based upon the aggregate percentage of the student in Class 12th Exams subject to the aggregate percentage being at-least 60%. Rank in merit list will be based on the aggregate percentage obtained by the candidate in the class 12th examination and in case of percentage being same, higher rank will be assigned to the older student based on Date of Birth.</p> <p>It may be noted that the admission granted will be purely provisional in nature, subject to the candidate meeting the eligibility criteria as mentioned in Section 5.3 of the Admission Brochure 2020-2021 (points a to c), available at university website.</p> <p>The onus of meeting eligibility is totally the responsibility of applicants as such in case, applicant is found to have failed to meet the eligibility criteria defined by the university in admission brochure 2020-21 with revisions, if any (or credentials claimed by him/her through various online communications from time to time) on verification of relevant educational documents etc. at any point of time later on also, the provisional admission offered, if any earlier, by the University shall stand terminated without any further notice and the fee submitted by such applicants will be forfeited.</p> <p>Further, decisions regarding number of seats, cut-offs of merit lists, lists of provisionally selected candidates to be prepared/declared from to time and other necessary decisions/communications shall be done by the centralized Admission Committee constituted for B.Tech./B.Arch. under chairmanship of Dean-FoE, with prior approvals/intimation of competent authority, as deemed fit.</p> |
