## NOTIFICATION

With respect to Minutes of the Meeting of the 19th Executive Council circulated on 21th June 2013 to all the members concerned and in pursuance to Item No: 19.16.3 sub point 4.16.3 of the Minutes of the Meeting, the Executive Council has approved the Grant of Assistantship to the students Joining Ph.D. programme at SMVDU on Full time basis who have qualified UGC NET/CSIR/GATE National level Test. These Students shall be provided an Assistantship as per UGC norms for JRF which is at present Rs. 14,000/- per month for first two years and Rs. 15000/- per month for next one year along with a contingency grant of Rs. 12,000/- per year for the initial two years and a total of Rs. 25,000/- for the third year or till the time he/she submits his/her thesis.

The Scholar shall be required to render 10 hours per week of academic support for the School/ College/ University as assigned by the Director of the concerned school. This will be outside his/her normal academic work. The assistantship will continue subject to his/her satisfactory academic performance, defined by minimum SGPA of 7.5 in the preceding semester for the minimum required earned credits and/or his/her satisfactory performance in the Comprehensive Examination, research work and discharge of responsibilities assigned under the Assistantship Scheme. The Assistantship may be suspended or terminated if the said conditions for the Assistantship award are not met.

The maximum period of the Assistantship shall be 3 years for the Ph.D. programme extendable by one more year subject to review of performance by the CRC of the concerned School/College and with the approval of the Vice Chancellor.

Further, such of these students /research scholars who are entitled for award of JRF by UGC NET or similar such test conducted by CSIR/DBT etc and shall be receiving the fellowship from these Statutory Authorities, therefore, in their case the University shall not be paying any assistantship.

The above shall be applicable to the candidates admitted to the Ph.D programme at SMVDU w.e.f the Academic Session 2013-14.

Further a provision for a minimum of 05 research fellowships in each of the Schools of study shall be created with further permission to transfer the available slots from one School to another which may remain unutilized during an Academic year. However such transfer of slots may be adjusted in subsequent years.

This issues with the approval of the Hon'ble Vice Chancellor.
