OFFICE ORDER

Sub: Appointment as DST-INSPIRE FACULTY

Consequent upon the INSPIRE Faculty award – Offer Letter [DST/INSPIRE/04/2017/001350], dated:24th July 2017, in favour of Dr. Mohd Fareed [Faculty Registration No.IFA17-LSPA83]; his subsequent request for starting DST-INSPIRE Faculty Programme at SMVDU and as approved by the Hon'ble Vice Chancellor, sanction is hereby conveyed for accepting Dr. Mohd Fareed under the DST-INSPIRE Faculty Programme at Department of Biotechnology, SMVDU with immediate effect, as per the terms and conditions as notified by DST under the above offer letter:

1. The above DST-INSPIRE Faculty award is tenable for a period of 5 years from the date of joining. The awardee [Dr. Fareed] and the host institution [SMVDU] shall sign an "Undertaking" for implementation of the Award in the format prescribed by DST. His subsequent appointment against a permanent position in SMVDU after completion of the above Faculty Award shall be subject to availability of a vacant position in the Department of Biotechnology, his fulfilling the eligibility conditions & recommendations of the selection committee as per norms and approval of the Hon'ble Chancellor to his appointment.
2. He shall be eligible to receive a consolidated fellowship amount equivalent to that of an Assistant Professor of an IIT [i.e., ₹.80000/- p.m.] plus 3.3% annual increment, and a research grant of ₹.35 lakh rupees for 5 years, i.e., ₹.7 lakhs per year.
3. The above grant shall be utilized for incurring expenditures under all Recurring and non-Recurring budget heads like ad-hoc Manpower cost, Consumable, Equipment, except Travel, Contingencies and Overheads which will be limited to 10% (i.e. ₹. 70000 per year), 10% (i.e. ₹. 70000 per year) and 5% (i.e. ₹. 35000 per year) respectively.
4. The INSPIRE Faculty may engage a research staff out of the Research Grant support during the Award tenure of 5 years.
5. He shall provide a budget proposal with detailed break up as above for utilization of Research Grant to DST-INSPIRE through the Host Institution and the Awardee/ Host Institution shall adhere to the approved break up for entire period of 5 years.
6. He shall administratively be governed by the prevailing rules and regulations of the Host institution [SMVDU], especially on all types of leaves and other matters.
7. He shall report to HOD Biotechnology, for further assignment of his duties.
