#### **ADDENDUM**

# **SUB: ADVISORY IN VIEW OF COVID-19 PANDEMIC**

In continuation to the Advisory issued vide no. SMVDU/Adm/Estt./20/934 dated: 10<sup>th</sup> July 2020 and in view of the rapid rise in COVID-19 cases in the nearby surroundings of SMVDU Campus (i.e Outside Main Gate, Colony / Hospital area), it is enjoined upon all Teaching / Non-Teaching Staff / Outsourced staff / Residents and other concerned to strictly follow the Standard Operating Procedures (SOP's) laid down by the authorities w.r.t. the prevention of local and limited community transmission of the Novel Corona Virus.

Also, keeping in view of the recent spike in the no. of COVID-19 positive cases adjoining SMVDU Campus boundary, the following precautions shall be strictly followed as enumerated below: -

- No outsider shall be allowed to enter SMVDU Campus without permission of the University Authorities.
- An individual while entering the campus must wash or sanitize his/her hands with sanitizer or soap & water available at the main gate and he/she shall be allowed to enter only after washing / sanitizing of hands. Hand-wash to be prioritized over sanitizer. Provision for hand wash & sanitizer preferably with a touch-free mechanism shall be made available at all entry points and common areas, especially at the main Gate no. 1 by the Security Officer.
- Mandatory thermal scanning of everyone entering the campus is to be done.
- All vehicles entering the campus should be disinfected by spray mandatorily, for which adequate provision shall be made by the Security Officer in consultation with the Transport In-charge, who shall utilize the services of Bus conductors for the same.

Outsourcing staff residing in the nearby colony/village area shall park their vehicles outside the main gate and must follow the SOP's w.r.t washing hands, screening of body temperature, wearing masks, while entering SMVDU Campus. No outsourcing staff shall be allowed to bring his/her vehicle inside the campus.
