## **OFFICE ORDER**

With reference to an application submitted by Dr. Rakesh Kumar, Assistant Professor, School of Biotechnology forwarded by Head, SoBT & Dean, FoS and recommended by Committee constituted to review the requests received from the faculty members for grant of PDA and as approved by the Competent Authority, Sanction is hereby accorded in his favour for the following:

- 1. Further, he must submit the re-imbursement request by or before the 20<sup>th</sup> of March of the current financial year, otherwise, the order issued w.r.t. financial assistance under PDA be considered as null and void and no financial assistance shall be provided to him.
