NOTIFICATION

<u>Sub: Consideration of medical re-imbursement claims in view of adoption of Ayushman Bharat PMJAY SEHAT Scheme for all employees and their dependents, who are domicile of J&K UT</u>

The Government of J&K has introduced Ayushman Bharat -PMJAY, SEHAT Scheme which provides free health insurance cover to all the citizens of J&K for Rs 5 lakhs per family per year on floater basis. In this regard approval of the Competent Authority is hereby conveyed for the adoption of Ayushman Bharat PMJAY SEHAT Scheme for all employees and their dependents, who are domicile of J&K UT, and shall be applicable w.e.f. 1st April 2022.

Henceforth, all employees who are domicile of UT of J&K shall avail the above-mentioned scheme for their and their dependents medical reimbursements under the Ayushman Bharat -PMJAY, SEHAT Scheme. The medical claims of such employees and their dependents, who are eligible under the scheme shall be considered for reimbursement under medical reimbursement policy of SMVDU, only for the amount beyond the insurance cover (i.e. Rs. 5 lac per family per year) being provided under the SEHAT insurance scheme.

It is further clarified that the medical expenses incurred on the treatment of life consuming diseases outside hospital/institute shall continue to be reimbursed as per the Medical reimbursement policy of SMVDU.

For rest of the employees and their dependent the existing medical reimbursement policy of SMVDU shall be applicable.

The above is, however, subject to ratification by the relevant Statutory bodies.

This issues with the approval of the Competent Authority.
