## OFFICE ORDER

**Sub: "Grant of permission (on ex-post facto basis) for attending International Inter disciplinary Conference on Energy, Nano Technology and IOT (via online mode) at NIT Puducherry w.e.f. 02<sup>nd</sup> – 04<sup>th</sup> February 2023 with financial assistance from PDA".**

With reference to an application submitted by Dr. Ankush Raina, Assistant Professor, School of Mechanical Engineering forwarded by Head, SoME & Dean I/c, FoE and recommended by Committee constituted to review the requests received from the faculty members for grant of PDA and as approved by the Competent Authority, Ex-post facto sanction is hereby accorded in his favour for the following:
