Sub: "Grant of permission (on ex-post facto basis) for attending International Conference on Energy, Nano Technology and Internet of Things (ENT 2023) by VIRTUAL MODE w.e.f. 02nd – 04th February 2023 at National Institute of Technology Puducherry, Karaikkal with financial assistance from PDA"

With reference to an application submitted by Dr. Eswaramoorthy Muthusamy, Professor, School of Mechanical Engineering forwarded by Dean I/c, FoE and recommended by Committee constituted to review the requests received from the faculty members for grant of PDA and as approved by the Competent Authority, Ex-post facto sanction is hereby accorded in his favour for the following:

- a. Grant of permission in his favour for attending International Conference on Energy, Nano Technology and Internet of Things (ENT 2023) by VIRTUAL MODE for presentation of his research paper entitled: 'Performance evaluation of Solar air heater with and without thermoelectric generator' at National Institute of Technology Puducherry, Karaikkal w.e.f. 02nd – 04th February 2023.
- a.
