Sub: "Grant of permission (on ex-post facto basis) for attending National Conference on Advanced Materials and Manufacturing Technologies (AMMT 2023) w.e.f. 23rd – 24th February 2023 at CSIR-NIIST, Thiruvananthapuram with financial assistance from PDA".

With reference to an application submitted by Dr. Ram Prakash, Assistant Professor, School of Physics forwarded by Head, SoP & Dean I/c, FoS and recommended by Committee constituted to review the requests received from the faculty members for grant of PDA and as approved by the Competent Authority, Ex-post facto sanction is hereby accorded in his favour for the following:

- Grant of permission in his favour for attending National Conference on Advanced Materials and Manufacturing Technologies (AMMT 2023) for poster presentation of abstract of his research paper entitled: 'Structural, Optical and Spectroscopic analysis of Dy doped ZrO' at CSIR NIIST, Thiruvananthapuram w.e.f. 23rd – 24th February, 2023.
