Above 50,000 & up-to 1,00,000 AIR(CRL) in JEE (Mains) Examination	Full Tuition Fee waiver for first 03 semesters
Note: The student has to maintain a minimum CGPA of 7.50 with no backlogs in each semester for continuation of scholarship.
