Payable upto 30,000 AIR(CRL) in JEE(Mains) examination	Full tuition fee waiver for first 05 semester
Above 30,000 and upto 50,000 AIR(CRL) in JEE(Mains) examination	Full tuition fee waiver for first 04 semester
Above 50,000 & upto 1,00,000 AIR(CRL) in JEE(Mains) examination	Full tuition fee waiver for first 03 semester

For B. Arch.

Payable upto 500 AIR(CRL) in JEE(Mains) examination	Full tuition fee waiver for first 05 semester
Above 500 and upto 1500 AIR(CRL) in JEE(Mains) examination	Full tuition fee waiver for first 04 semester
Above 1500 & upto 3000 AIR(CRL) in JEE(Mains) examination	Full tuition fee waiver for first 03 semester
