Sub: "Grant of permission (on ex-post facto basis) for attending 2nd International Conference on Sustainable Resilient Built Environments (via online mode) at Manipal, Karnataka, India w.e.f. 19th – 21st December 2022 with financial assistance from PDA"

With reference to an application submitted by Dr. Yatheshth Anand, Assistant Professor, School of Mechanical Engineering forwarded by Head, SoME & Dean I/c, FoE and recommended by Committee constituted to review the requests received from the faculty members for grant of PDA and as approved by the Competent Authority, Ex-post facto sanction is hereby accorded in his favour for the following:

- a. Grant of permission in his favour for attending 2nd International Conference on Sustainable Resilient Built Environments (via online mode) being organized by Manipal School of Architecture & Planning, MAHE, Manipal India in collaboration with Deakin University, Australia, International Islamic University Malaysia, University of Moratuwa, Sri Lanka and Auckland University Technology, New Zealand for presentation of his research paper entitled: 'Experimental assessment of thermal comfort in the enclosed space of a residential building in Jammu region: A case study' at Manipal, Karnataka, India w.e.f. 19th – 21st December 2022.
