
**Sub: "Grant of permission (on ex-post facto basis) for attending IX International Conference on Perspectives in Vibrational Spectroscopy (ICOPVS-2022) at UGC-DAE Consortium for Scientific Research in Indore w.e.f. 13<sup>th</sup> - 17<sup>th</sup> December 2022 with financial assistance from PDA"**

With reference to an application submitted by Dr. Ram Prakash, Assistant Professor, School of Physics forwarded by Head, SoP & Dean, FoS and recommended by Committee constituted to review the requests received from the faculty members for grant of PDA and as approved by the Competent Authority, Ex-post facto sanction is hereby accorded in his favour for the following:

1. Grant of permission in his favour for attending IX International Conference on Perspectives in Vibrational Spectroscopy (ICOPVS-2022) for poster presentation of abstract of his research paper entitled: 'Structural and FTIR Spectroscopic analysis of Dy<sup>3+</sup> doped ZrO<sub>2</sub>' at UGC-DAE Consortium for Scientific Research in Indore w.e.f. 13<sup>th</sup> - 17<sup>th</sup> December 2022.
