OFFICE ORDER

Sub: "Grant of permission to attend 2023 3rd International Symposium on Instrumentation, Control, Artificial Intelligence and Robotics (ICA-SYMP 2023) at Faculty of Engineering, Kasetsart University, Bangkok, Thailand w.e.f. 18th – 20th January 2023 with financial assistance from PDA".

With reference to the application submitted by Dr. Sachin Kumar Gupta, Assistant Professor, School of Electronics & Communication Engineering, forwarded by Head, SoECE & Dean I/c, FoE and recommended by Committee constituted to review the requests received from the faculty members for grant of PDA and as approved by the Competent Authority, Sanction is hereby accorded in his favour for the following:

- a) Grant of permission in his favour to attend '2023 3rd International Symposium on Instrumentation, Control, Artificial Intelligence and Robotics (ICA-SYMP 2023)' being organized by ECTI, AIAT, TRS & IEEE Thailand Section w.e.f. 18th 20th January 2023 for oral presentation of his research paper entitled: 'Asynchronous and Synchronous Federated Learning-based UAV's' at Faculty of Engineering, Kasetsart University, Bangkok, Thailand with financial assistance out of his PDA from the block period of 03 years i.e 2020-23 and FY 2021-22 & 22-23, as per University rules.
- b) Re-imbursement of 'Registration fee' amounting to TBH 9000 (Rs. 21,000/- approx.), VISA Fee, Medical Insurance, TA (i.e Air travel by Economy class by shortest possible route), Train and local charges from SMVD University campus to Bangkok, Thailand & back and Per Diem (DA), as per University rules, subject to the maximum balance (i.e Rs. 1,40,000/-) available in his PDA account.

Dr. Sachin Kumar Gupta shall however, separately apply for the kind of leave as may be due to him providing therein the leave arrangement of his teaching load & other assignments to the Dean (AA) through Head of the School for the period of his absence, before proceeding for attending the above said Conference.

Dr. Sachin Kumar Gupta shall also submit his participation certificate and a report of attending the aforesaid Conference to this office after resuming his duties at this University, along with his joining report. He shall also present a seminar on the same topic in his School for the benefit of all Faculty members & Students.

Further, he must submit the re-imbursement request by or before the 20th of March of the current financial year, otherwise, the order issued w.r.t. financial assistance under PDA be considered as null and void and no financial assistance shall be provided to him.
