Subject: Appointment of CI and Co-CIs regarding the Institutional Consultancy Assignment for landscape/ redevelopment of Bathing Ghat-1 (Phase-1), Banganga, Katra, J&K (UT).

With reference to the proposal from Ar. Aditya Kr. Singh, Associate Professor & Head, SoALD; letter of appointment vide No.CO/Dev/604/1132, dated 11.07.2022 from Dy. Chief Executive Officer, SMVD Shrine Board, Katra and as approved by the Competent Authority; sanction is hereby accorded to undertake the Institutional Consultancy Assignment for providing Comprehensive Architectural/ Structural/ Landscape/ Urban Design/ Interior Architecture Consultancy Services w.r.t. Project entitled "Landscape/ redevelopment of Bathing Ghat-1, Banganga, Katra, J&K (UT)".

Ar. Aditya Kr. Singh, Assoc. Professor, & Head, SoALD is hereby appointed as Consultant In-charge (CI) and other team members comprising of Dr. V. K. Dogra (Assoc. Prof), Ar. Abhiney Gupta (Asstt. Prof.), Ar. Navin Gupta (Asstt. Prof.), Ar. Abhimanyu Sharma (Asstt. Prof.) & Ar. Vishal Bhatti (STA), SoALD as Co-consultant Incharge (Co-CIs) for the said consultancy. The said consultancy shall henceforth be referred as 'CP/23/59'.

The estimated cost of the consultancy project is Rs.1,01,03,465/- (Rupees One crore, One lac, Three thousand, Four hundred & Sixty five only). The Consultancy fee is 2% of the project cost excluding GST. The University share will be 50% of total charges i.e. 01%. However, the consultancy fee paid to the individual consultant shall be liable for deduction of TDS at source, as per rules. The breakup of the consultancy charges is as under:-
