- 2. I/c Engineering Affairs committee to facilitate responsive and efficient delivery of the day to day maintenance and repair of building and engineering infrastructures across all the campus academic, administrative, commercial and residential buildings. And Creation of well defined structure for providing the maintenance facility to the faculty, staff and students of the University.

Directorate of Quality Assurance proposes to start a pilot project in which a total number of 12 cycles shall be purchased (6 each for Boys & Girls Hostel) and students will be encouraged to use these cycles within the University for commuting from one place to another. These cycles will be stationed outside the boys (6 cycles) & girls (6 cycles) hostels for usage by the students.
